Policy Objective: With the intention of empowering and strengthening accountability in financial spending, it was decided to allocate a fixed amount to department heads, Institution heads as well as Group Directors.

Based on the expense statements submitted and after reviewing the spending patterns in the past year, the guidelines for allocation of these funds stand revised with effect from 1st Oct 2024.

1. Given below is an easy reference table to understand the quarterly limits allocated to each of the Institutions of SCMS Group. All amounts mentioned in the table are for a quarter (3 months) only, starting 1st of Oct 2024.

2. The HOD/HOI will have the discretion to spend for the below purposes subject to the following conditions:
 - i. Guest Speaker Honorarium - Rs. 2,000/- per hour is the HOD limit beyond which it has to be escalated to the next level for fund allocation. Kindly ensure there are min. four visits in a semester OR min. three visits in a trimester
 - ii. Conduct of department Seminars (1 in a Semester per department)
 - iii. Purchase of books for the department / institution library. Kindly ensure books ordered are of the latest edition.
 - iv. FDPs (At least one FDP in a year, hosted by each department)

- v. Faculty and Staff training (based on Training needs identified by HOI)
 - vi. Student Support and Progression activities (as prescribed in NAAC/NBA/KTU guidelines)
3. The maximum amount allowed to be spent on one single event by a department is Rs.10,000/-. **In the event of the expenses exceeding the budget amount, the same may be escalated to the Head of Institution or Group Director as the case maybe for approval..**
 4. A detailed proposal listing out the event objective, expenses, resource person profile, etc. should be submitted to the Principal for his/her vetting, prior to sending out any written/oral communication to the resource persons or committing to the concerned faculty members or students.
 5. Transportation expenses of the resource persons, if any, will be borne by the Institution.
 6. Stationary purchases like paper, pens etc. connected to an event can be included but not otherwise, which is a budgeted expense for the Institution.
 7. Two or more departments can jointly conduct programs, wherein each department can spend not more than Rs.10,000/- for a single event.
 8. Expense statement post event has to be settled with relevant bills with the Finance Department, at Corporate office.
 9. Any kind of personal use or loan of these funds for faculty members or students is not permitted and will not be approved.
 10. Utilisation of dept funds will be audited every quarter.
 11. Unutilised funds for a quarter will not be carried over to the next quarter.
 12. The management of SCMS Group reserves its rights to increase or reduce the allocated amounts, depending on the fund utilization patterns.

We trust you will use your good judgment in utilizing these allocated funds.
