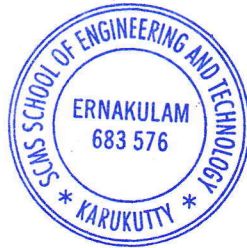

Faculty Development Program Financial Assistance Policy

The institution promotes continuous professional development and encourages its faculty to take initiatives to attend various trainings and professional development programs.

Objective:

The Faculty Development Program Financial Assistance Policy aims to support and encourage faculty members to enhance their professional development by attending relevant faculty development programs / Conferences / Workshops / Trainings / Professional Body Memberships. This policy outlines the eligibility criteria, application process, and terms for providing financial assistance.

Eligibility:

1. Full-time faculty members with a minimum of 1 years of service are eligible to apply for financial assistance.
2. The faculty development program must be directly related to the faculty member's field of expertise and contribute to their professional growth.

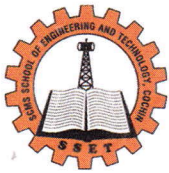
Limit of Financial Assistance:

1. The maximum financial assistance amount for Assistant Professor shall be Rs. 5000/- and for Associate Professors and Professors shall be Rs. 15000/-.
2. Financial assistance will be provided on a reimbursement basis, and faculty members must submit valid receipts or proof of attending the training or development program.

Financial Assistance Categories:

1. Registration Fees: The organization will cover the full or partial cost of the faculty development program registration fees.
2. Travel Expenses: Reimbursement for travel expenses (e.g., airfare, accommodation, transportation) may be provided based on the distance and the availability of funds.
3. Material and Resource Costs: Financial assistance may be granted for the purchase of relevant materials or resources required for the faculty development program.

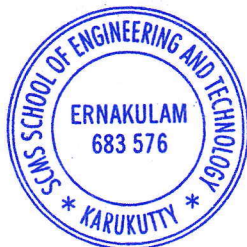
