- Caste and Income Certificates (In the case of SC/ST/OEC/OBH candidates only)
- Nativity Certificate, Valid Non Creamy Layer certificate -for communal reservation seat
- PD Quota- Certificate from Medical Board
- EWS quota- Only for forward community having income not above 4 lakh or should produce AAY/PHH certificate.
- Fee concession to children of Fishermen- certificate from Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board.
- Fee concession to inmates of Sri Chitra Home, Nirbhaya Home & Juvenile Home- certificate from Director, Women and Child development
- Candidates who passed their qualifying examination from Universities/Boards outside the State shall produce “Eligibility Certificate / Equivalency Certificate” from any of the Universities in Kerala.
- Applicant who is employed or a trainee in Government service, Scheduled Bank etc. should produce, at the time of interview, a relieving order and a certificate of good conduct from the Head of the office where the applicant is employed.

(C) **Hostel accommodation (available for Boys & Girls)**

Those requiring hostel accommodations have to fill up the application form and remit the following fees.

➤ Hostel caution deposit (Refundable)	- Rs. 5,000/-	} Rs. 11,255/-
➤ Advance Hostel Rent for six months (Rs. 2000/- per month x 6 Months)	- Rs. 2,000/-	
➤ One month advance towards mess fee	- Rs. 4255/-	

Note: On vacating the hostel, student should take hostel clearance from warden and vacate the room on the same day itself.

(D) **Transportation.**

Those requiring transport facility by College bus has to fill up the form and remit the fee for six months. Transport facility will be available from Vytilla, Thripunithura(Seaport Airport road), Thoppumpady, Valanjambalam, GCDA, Palarivattom, High court Junction, Vaduthala, Perumbavoor, Paravur, Kodungallur, Irinjalakuda, Pukkattupady, Muvattupuzha and Thrissur to College and back
