#### MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING is entered into on this day 10 September 2018 at Cochin, BY AND BETWEEN:

SCMS School of Technology and Management, hereinafter referred to as SSTM (which expression shall mean and include its legal representatives, transferees, assigns, et al), and having its main educational premises at Prathap Nagar, Muttom, Alwaye, Cochin 683106 and duly represented by its Principal, Dr. G. Sashi Kumar, the FIRST PARTY.

AND,

GLOBALFTI Pvt. Ltd., hereinafter referred to as GFTI, (which expression shall mean and includes its legal representatives, transferees, assigns, et al), having its registered office at No.806, Souravya Building, 10<sup>th</sup> – A Main Road, Binnamangala 1<sup>st</sup> Stage, Indiranagar, Bangalore-560038, duly represented by its Director, Mr. Anil Menon, the SECOND PARTY;

WHEREAS, SSTM is interested in offering to its students value added course such as ACCA (Association of Chartered Certified Accountants, UK) and GFTI an established and approved learning provider of ACCA(UK) in India is ready to take responsibility of delivering the program for SSTM.

IT IS MUTUALLY AGREED, AND HENCE THIS MOU WITNESSETH AS HEREUNDER:

 This MoU is effective from the date of signing of this MoU and shall continue to be in force for a period of three (3) years and it shall be reviewed every year. Any revisions or changes to fees or terms of this MoU will be in the form of addendums to existing MoU and will be made on mutual consent. Either party can terminate with 60 days notice, subject to completion of batches.

- The students interested in the program, who have joined SSTM solely for ACCA program or for any other course/s, shall be eligible for joining this course subject to general rules of admission of SSTM.
- GFTI proposes to conduct the ACCA Program in parallel to or integrated with the BBA/B.Com or any other program at SSTM.
- The fees [tuition fee + GST + book fee] to be collected for the said ACCA program, is as defined in the Schedule – A of this MOU.
- SSTM and GFTI shall be jointly responsible for enrolling the students and collecting the fees for the ACCA program.
- 6. In case SSTM collects the tuition + book fees then SSTM will pay GFTI complete fee as mentioned in this MoU after retaining its share of the tuition fee, within 7 days of collecting it from the studentor before commencement of program, whichever date is earlier.
- In case the minimum requirement of 10 students in a batch is not met then GFTI at its discretion shall combine these students at its nearest centre in Ernakulam.

# 8. DUTIES:

## I) GFTI shall

- a) Provide quality resource persons for conducting ACCA classes at SSTM premises.
- b) Put in place the schedule and all other requisites after mutual discussion with the Authorized Academic coordinator of the college
- c) Provide course material in the form of books as recommended by ACCA for a charge as mentioned in Schedule – A
- d) Promote the ACCA course at SSTM on the GFTI website
- e) Provide counseling /orientation sessions for students enrolling in the ACCA course at SSTM for no additional cost to the Eirst Party.

f) GFTI will provide necessary marketing support in terms of training the college counsellors.

# II) SSTM shall

- a) Offer the ACCA course to students of SSTM as well as the students approaching SSTM for various courses.
- b) Permit GFTI to conduct ACCA classes for the students of SSTM within its premises in Cochin.
- c) Provide suitably equipped rooms for academic purposes, including any audio/video facilities, as and when required.
- d) Appoint a coordinator from SSTM who will assist GFTI in scheduling classes, communicate with students, assist in registration formalities and provide all other operational support for running the ACCA program successfully.
- e) Allow GFTI to collect fees from students for the ACCA courses incase SSTM does not wish to take this responsibility.
- f) Promote the ACCA program using its channels of marketing as and along with the other course promotions.
- g) SSTM shall extend its support to GFTI so as to ensure the coordination and facilitation of ACCA course with the B.Com, BBA or any other programs.

# 9. Eligibility Clause

- a) Any student who is pursuing or completed class 12 or Pre-degree or any other course acceptable to ACCA with minimum of 65% marks in English & Maths or Accounts and a minimum of 50% in all other subjects and otherwise meets the general conditions of SSTM can be admitted.
- b) The students joining for the 1<sup>st</sup> year of degree can simultaneously join for the ACCA program.
- c) The parallel program is open to students who are in their 2<sup>nd</sup> and 3<sup>rd</sup> year of degree, as well as other students, if SSTM so desires

- 15 Notwithstanding anything contained in this MoU. For any matters not specifically covered by the MoU the parties shall mutually discuss the same and reach a consensus, and such agreement shall be documented, signed and shall be attached with the MoU for future reference and thereafter shall form part of this MoU.
- 16 Each Party shall release, protect, defend, indemnify and hold harmless the other Party from and against any and all losses, claims, judgments and awards arising out of:
  - i. injury, illness, disease or death suffered by each Party's personnel, and/or
  - damage or loss of each Party's property, arising out of or in any way relating to this MoU, howsoever and whomsoever caused.
- 17.Each Party shall pay all taxes, assessments and fees, if any imposed on it by the governmental authorities time to time in connection with this MoU.
- 18.Either party to this MOU may intimate its desire to make change/s to any of the clauses herein, except those which otherwise affects adversely the very purpose of this MOU. Upon mutual acceptance of the desired changes, an amended MOU may take effect from the date of the MOU so amended. The said acceptance of the change/s shall be intimated to the requesting party, in writing.
- 19.Neither party to the MOU herein shall be liable for any type of loss or damage which may be caused due to the Acts of God, strike, civil disturbances, et al.
- 20.Both the parties to the MOU agree that the aggrieved party shall put forth its grievances in the form of written notice to the other party, and the same shall be resolved through mutual discussions and negotiations, acknowledging the requirements of the students' future.







This MoU shall be governed by and construed in accordance with the laws of India. Any dispute arising under this MoU shall be discussed and mutually resolved by the Parties. If such mutual discussions do not settle the dispute within sixty (60) days, the Parties agree to refer the matter for adjudication by the relevant courts in Bangalore. WHEREAS, this MOU shall be interpreted as per and includes the rules of interpretation of such MOUs, as specifically prescribed by the Law/s for the time being in force.

WHEREFORE, this MOU is entered into on the date, month and year abovementioned, and the parties above mentioned have set their seal and signature/s as hereunder.




