shall follow and adhere to the Regulations, guidelines and directions issued by AICTE from time to time and the undertaking / affidavit given by the institution along with the application submitted by the institution on portal.

1. The duration of courses shall be for a total period of 5 years spread over ten semesters.
2. The course shall provide an undergraduate degree in 3 or 4 years,(BCA/BAC) followed by a masters degree in five years (MCA) as below
 - a. Award of a bachelor's degree (BCA) at the end of three years, if one wishes to discontinue the studies
OR award of a Bachelor's degree in Applied Computer Applications (BAC)at the end of four years
AND
 - b. award of Master's degree in Master of Computer Applications(MCA) at the end of five years.

Note : (#BAC shall not be awarded to one who has acquired a BCA degree however, a certificate for credits acquired at 4th year shall be given)

3. Admissions to these courses shall be based on scores at the Common Aptitude Test. However the admissions in 2014-2015 shall be affected on basis of marks obtained at 12th (with Physics and Mathematics as compulsory subjects along with one of the Chemistry/Biotechnology/Biology/Technical Vocational subject) through a separate merit list created for the purpose.
4. The State/UT admission authority shall affect the admission of this course.
5. The Admissions shall be effected only after obtaining affiliation for this course, from the affiliating body.
6. This course should be conducted in the general/first shift working.
